1. Games will be played at **Memorial Drive Presbyterian Church** - 11612 Memorial Drive, 77024 (intersection of Memorial Dr with Blalock and Piney Point/Fondren), **Pines Presbyterian Church** – Address: 12751 Kimberley, 77024, Phone: 713-467-2234, or **Memorial Church of Christ** – Address: 900 Echo Lane, 77024 (across from Memorial High School).
2. Coaches should contact League Commissioner and opposing coach if unable to play as scheduled. Games will not be re-scheduled.
3. Game times are in 1.5 hour time slots. The first 40 minutes of each time slot is the official practice time for the two teams. The remaining time is devoted to game play.
4. Each player from both teams will shoot one free throw at the end of each half with the points contributing toward the team’s total for the game. (Each team will shoot the same number of free throws. If one team has fewer players, then players on that team who miss their first shot will shoot the additional free throws.)
5. Won/loss records will not be maintained.
